Safety

The safety of our players and participants is of utmost importance. Our Lighting Policy and Heat Index Guidelines are available on our website – www.ironriversoccer.com.

For the safety of the players, neither football cleats nor any sport shoe with a cleat at the toe will be permitted. These pose a risk to soccer players. Please be advised that nothing other than soccer shoes or regular tennis/running shoes will be allowed by the referee.

We are bound by SAY (Soccer Association for Youth out of Cincinnati, Ohio) National rules, and they have determined that no earrings, not even if taped or replaced by strings or the soft sport substitutes, are permitted on the soccer field. If your child has plans to pierce her ears, since new earrings need to stay in place for a number of weeks, please wait until after the soccer season to have ears pierced or have them done in sufficient time to heal before the season begins.

Courtesy

Good sportsmanship is expected by the spectators and the kids playing soccer. Players, coaches, and parents are expected to exemplify the *Code of Ethics & Behavior* principles made available each season. For the sake of courtesy to players and spectators, we ask that people refrain from smoking at the field and from bringing dogs to the field. Since games and practices are typically completed within an hour, we feel this is a reasonable request to make. Please inform friends and relatives who support your child with attendance at games that we are requesting no smoking and no dogs during games and practices. We appreciate everyone's cooperation and are looking forward to a great season.
